DIRECTIONS TO THE TRIAL SITE

PLEASE BE AWARE THAT THE ELIZABETH STAMPEDE WILL BE HELD DURING OUR WEEKEND. ALTHOUGH THE EVENT IS HELD OFF CO-86, TRAFFIC DELAYS MAY BE A CONCERN. PLEASE PLAN FOR ADDITIONAL TIME TO ENSURE ON TIME ARRIVAL OR SEEK ALTERNATE DIRECTIONS FROM BELOW. THAT EVENT STARTS AT 9AM ON SATURDAY AND 8AM ON SUNDAY.

NO ENTRY VIA FOREST TRAIL

From the south/Colorado Springs: Take 1-25 to County Line Rd, 14 miles. Turn right on County Line Rd. Drive 5 mile to CO-83. Turn left onto CO-83. Drive 10 miles to Russellville Rd. Turn right on Russellville Rd. Drive 7.8 miles to Deerfield Rd. Turn right on Deerfield Rd. Drive 2 miles to CO-86. Turn right onto CO-86. Drive 6 miles to CO-21. Turn left onto CO-21. Drive approximately 2 miles to CR 146. **Turn right onto CR 146.** Destination will be on the left.

From the north: With Tolls – I-25 South to exit 194. Take E-470 towards Limon. Go 5.5 miles to exit 5, CO 83S/S Parker Road. Go 4 miles to Hess Rd. Turn left onto Hess Rd. Hess Rd becomes Hilltop Rd. Drive 8 miles on Hess/Hilltop Rd to Singing Hills Rd. Turn left onto Singing Hills Rd/County Rd 166. Drive 6.5 miles to County Road 21. Turn right on County Rd. 21. Drive approximately 5 miles to CR 146. **Turn left onto CR 146.** Destination will be on the left.

MOVE UPS

All pre-trial move-ups must be received by 5pm MT, Monday, June 2, 2025. AKC requires move-ups to be in writing. You may send an email for a move-up to Donette Belknap agilitydogs6@outlook.com with your name, your dog's call name and what class you want the dog moved from and moved to. There will be no move-ups the morning before the start of the trials. Move-ups between trials (Saturday to Sunday) will be offered if space is available. Move-ups must be received in writing no later than 30 minutes after the conclusion of the class they are moving up from for the subsequent days.

PARKING

Once you enter the grounds, continue on the driveway keeping right at the fork going up hill. The parking lot will be on your right. Please pay attention to any cones marking the parking area as they are there to indicate potential site line boundaries. Although there is ample parking, please be considerate of spreading canopies or crates beyond your parking area. There will be a Traffic coordinator to assist you. Exiting of the property is the reverse of the above. ***Please drive slowly. Those with a state-issued handicapped sticker should notify the Trial Chair for special parking accommodation.***

CRATING

Crating will be solely in or around private vehicles in the designated parking areas. There is not room for RVs or trailers. No overnight camping. Weighted canopies no larger than 10' x 10' are permitted if they do not block flow of traffic or prevent another vehicle from entering or exiting. For safety reasons, **XPens are NOT allowed.**

PET RELIEF AREA

Please relieve your dogs near the parking area only and do not allow urination on any man-made object. Once you pass the buildings, no pottyng is allowed as you may contaminate an area to be used in other searches. As always, *failure to pick up after your dog will result in excusal from the trial with no refund*. If you are caught without a bag, please ask someone or mark the area and immediately come back to clean up.

WHO DO I ASK WITH QUESTIONS?

Committee Members and Key Volunteers will be wearing a **purple vest** when not competing. If they can't answer your question, they will have radios to ask someone who can. The Trial Chair is Peg Wier; the Volunteer Coordinator is Lynnea Britton.

IMPORTANT LOGISTICS INFO

Due to the unique and exciting search areas, we have a very full trial. The key to trial success is efficiency. As stated in the premium, search areas can be a little bit of a walk from the parking lot; Advanced Interiors has three steps with railing. Please potty your dogs before your class briefing and walk through! The first dogs will be expected to take their positions in line as soon as possible after the conclusion of the briefing. The exact time expectation will be indicated during that meeting.

All classes will be run in gate order unless there is a conflict with another class with volunteers having the opportunity to run first. Please check in with the Gate Steward prior to the briefing and discuss any conflict moves. Keep in mind that any move you make may cause a conflict for someone else; be flexible with and kind to the volunteer! See below for class and level orders.

Gate stewards will call for the next 3 dogs. If a handler does not respond to the Gate Steward and the next dog is available, the missing dog will be moved down in order, either as soon as can be accommodated or to the end of the order. Per AKC regulations, it is the handler's responsibility to be available when required with no club responsibility to track down said handler. There will be a volunteer in the parking lot to inform participants on which dog is going into the ring and announce the next 3 dogs. *Please take a picture of the gate board before you leave the briefing so you can prepare.*

Unless otherwise advised during the briefing, the main path will be the sidewalk between the Trial Secretary (TS) building and the Judges' house. Please keep both dogs and humans on the pavement, especially if you see cones marking off an area.

RESTROOMS:

Restrooms are located at the far side of the search areas and may be accessed by the path to the left of the parking area and Trial Secretary building. See RR on the map below.

BUT WHAT TIME WILL MY CLASS START?

We get a lot of questions on "when will my class start" for trials. We cannot give out times other than the start of the first class of the day. However, here is a way for you to estimate when your class MAY start running:

In the Regulations for AKC Scent Work (on the AKC website under "Scent Work" "Regulations Resources"), page 18 under Chapter 3 Section 22 it lists an estimated time per entry per class/level.

Below, we provide entry counts as of the pre-entry closing along with the order the classes will run. You can multiply out the estimated judging time per run x the entries in each class to get a rough estimate. However, please note that this doesn't include absent dogs, move-ups, day-of-show/late entries, judge breaks, lunch breaks, etc. And runs don't always last the "estimated" judging time per run. **There are no refunds/credits/moves for missed runs. Calculate at your own risk!**

JUDGING ORDER

Due to Judges' time limitations, per AKC rules, a third judge has been added for **Excellent Interior and Masters Containers both days**. Both classes will run in the stated order, not concurrent with any other Interior or Container classes*. **Handlers entered in these classes may choose to withdraw their dogs in writing to the Trial Secretary for a full refund of the classes with a JUDGE CHANGE ONLY.**

Classes will run in the order indicated, completing each level in turn before moving to the next. Although an available dog may be asked to run earlier to keep the flow of dogs moving (so arriving slightly early is appreciated), **there will be no "all call/cattle calls" allowed.** Each pair of classes will be run concurrently.

Saturday Pairings and Order: Class Order: Novice to Masters
Buried to Containers, All Levels
Exterior to Interior, All Levels

Sunday Pairings and Order: Class Order: Masters to Novice
Buried to Containers, All Levels
Interior to Exterior, Masters and Advanced
Exterior to Interior, Excellent and Novice

After running of any volunteers entered in that class, handlers running only one class of a pair will run first in order. If running different dogs in each class, run your Container or Exterior dog first in order and the Buried or Interior dog last in order.
