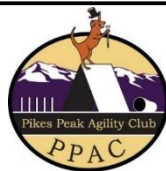
DRAW CLOSING ON August 27, 2025 6:00pm MDT

Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

MOVE UPS

There will be no move-ups between Excellent & Master, unless the # of master runs allowed for the trial and judging hours are not exceeded. This includes any excellent titles earned after the random draw (including excellent titles earned at the Mountain States DTC

Trial), incorrect entry forms and titles earned on Saturday (10/4). **No refund will be issued if you cannot move up because of trial limits.**

All other move ups between trials will be offered. Move Ups are for next day only and must be turned in within 30 minutes of the completion of the class.

WAIT LIST INFORMATION

PPAC is offering a wait list to fill openings created by withdrawn entries after the trial’s closing date/time. A maximum of 50 entries per day will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to August 24, 2025. No entries may be withdrawn with a refund after closing on August 24, 2025 unless the withdrawn entry is replaced by a wait listed entry. Any wait listed entry that does not move off the wait list, their check(s) will be shredded.

No entries will be accepted by phone, email, or fax. No hand delivery within 24 hours of trial open date/time. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Inquiries may be directed to Maureen Baumtrog mkbaumtrog@gmail.com. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry. A \$25.00 collection fee will be added to the amount of each returned check.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include a warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handlers' Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handlers' Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

The club shall designate a warm-up area. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area along with blank box(es). This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

GUARANTEED WORKER SLOTS

Pikes Peak Agility Club is offering guaranteed worker entries. A maximum of 15% of the trial entry limit may be reserved for volunteer workers who commit to working multiple classes per day. Please reach out to the Trial Chair or Volunteer Coordinator (Lynnea Britton: laabritton@gmail.com) to be considered.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors, on dirt, matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

Search Area Sizes will be as required in the *Regulations for AKC Scent Work*.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5. Section 35 of the Scent Work Regulations state “No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area”.

Spectator Area. Spectators are encouraged. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide.

Crating: Crating is within or immediately adjacent to personal vehicles. Weather in Colorado can be tricky! Please be prepared for all weather conditions. Be considerate of others if using a canopy and stake down for wind. No X-pens are allowed.

RV Parking is available, but is located up the hill from the trial site. Please contact the fairgrounds directly, 719-520-7880. See additional information under Motels & RV information.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds. Dogs may not relieve themselves outside of designated areas and especially not on any non-organic item on the show site.

No food will be provided on sight so competitors should come prepared with their own snacks, beverages and lunch.

High in Trial

Only teams who participate in the same difficulty level in all elements offered (Container, Interior, Exterior, Buried) and qualify in each are eligible to win **High in Trial**. One High In Trial winner is chosen per difficulty level; there is no separate High In Trial for the Novice A and Novice B sections. The High in Trial is determined by adding the team's faults across the elements. If there is a tie based on faults, then the team's times across the elements will be summed and the faster-finishing team will win. The High in Trial award is not recorded by the AKC Teams winning High In Trial.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and **retractable leashes may not be used when on trial grounds** (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

If an entered dog becomes injured or sick after the closing date, a 50% refund of that dog's entry fee is offered. The refund will be in the form of voucher to be used at a future

PPAC Scent Work Trial. The trial secretary must be notified in writing via e-mail, by 5:00pm the day before the 1st day of the weekend trials. i.e., Thursday by 5:00pm for a 3-day trial that is Friday, Saturday & Sunday. A letter from a Vet must be provided to the trial secretary no later than 3 business days after the last day of the weekend trials.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Conflicts will be managed by the Gate Steward or Trial Chair only. Classes will not be held to wait for a dog/handler to appear.

Exhibitors MUST check-in EACH day they are entered.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
